Remember the four 'R's to safeguarding

- Recognise (go with your gut feelings, if it doesn't feel right- talk to your CWO or the BJA safeguarding Team. <u>Child Protection - British Judo</u> and <u>Introduction to</u> <u>Safeguarding - British Judo</u>
- Respond to the needs of the person at risk or something they have told you talk to your CWO or the BJA safeguarding Team. <u>Child Protection - British Judo</u> and <u>Introduction to Safeguarding - British Judo</u>
- **Report** if someone is in immediate danger or risk, call emergency services on 999. Report all concerns to your CWO or the BJA safeguarding Team. <u>Child</u> <u>Protection British Judo</u> and <u>Introduction to Safeguarding British Judo</u>. From February 2024, this can be done via MyVoice
- Record- pass to the safeguarding team and we will save in our case management system.
