# 2025 JUNIOR WORLD CHAMPIONSHIPS SELECTION PROCEDURE 1-5 OCTOBER 2025 (TBC) | VENUE (TBC)

## INTRODUCTION

The Junior World Championships is a PERFORMANCE PATHWAY CHAMPIONSHIPS for athletes who have the potential to perform and medal at this level of competition and in the future, will be eligible for consideration for selection.

The selection of athletes to represent Great Britain at the 2025 Junior World Championships will be made according to this selection policy.

To Note - It is conditional of being selected for the 2025 Junior World Championships, that all selected athletes follow the GB Preparation Programme.

Athletes should note that for all major championships, each delegation may enter a maximum of 9 entries in total for men and 9 entries in total for women, and in each weight category of men or women, a maximum of 2 athletes can be entered. For this championship all athletes must be born between 2005 and 2010.

### **SELECTION PROCESS**

- 1. The GB Team for the 2025 Junior World Championships (wk40 **TBC**) will be selected as follows:
  - Week 31: w/c Monday 28 July (post JNR GBR European Cup) First Selection Stage
  - Week 37: w/c Monday 8 September (post JNR European Champs) Final Stage Selection

#### CRITERIA

NOTE: 2025 European based, JNR Continental Open (JNR European Cups) events as identified below on the JNR World Ranking List, will be used for selection purposes – ie JNR BIH, ESP, POR, POL, ITA, TUR, LTU, AUT, GER, CZE, HUN and GBR.

Bremen JNR International (Male) and Thuringia JNR International (Female) are NOT Junior European Cups but have been classified as events that are of the level to the identified Junior European Cups and will be considered as such through the selection process.

In sections 2 and 3, reference to medals achieved in 2025, refers to the definitive Performance Timeline from **1 January 2025 to 7 September 2025**, including ALL identified events and IJF World Ranking events during this period.

2. A maximum of one athlete selection per weight category will be prioritised for selection to the GB Team delegation at the First selection stage where he / she achieves one or more of the following levels of performance (prioritised in descending order):

- 2.1. 1 x SNR IJF WR Event Grand Slam, Grand Prix Top 7 placing
- 2.2. 1 x SNR European Open medal
- 2.3. 2 x SNR European Cup medals
- 2.4. 3 x JNR European Cup medals

If two or more athletes in the same weight category achieve the criteria outlined in section 2, the selection panel will select one athlete with the highest performance level based on using objective data such as overall medal(s) placing, strength of events, number of wins and number of losses.

- 3. Athletes will be considered for selection at the Final selection stage for the remaining spaces available in the GB Team delegation after selections are made in SECTION 2, where he / she achieves one or more of the following levels of performance (prioritised in descending order):
  - 3.1. 2025 Junior European Championships top 7 placing
  - 3.2. 1 x Senior European Open top 7 placing plus a minimum of 1 x JNR European Cup medal
  - 3.3. 1 x Senior European Cup medal plus a medal at a Junior European Cup
  - 3.4. 2 x Junior European Cup medals
  - 3.5. 2 x Cadet medals (European Cup, European Cadet Championships or EYOF) plus a minimum of 1x JNR European Cup top 5 placing
- 4. In the instance of more than two athletes achieving the same levels of performance set out in sections 2 and 3 in any one weight category, the Selection Panel shall decide which athlete(s) to select taking into account the factors listed in section 5 and the provisions of section 7.
- 5. When considering selections, in addition to the level of performance achieved by an athlete, the Selection Panel shall take into account, and give such weight as it considers appropriate, to the following factors:
  - 5.1. Any athlete who may have been injured and had a Junior European or Junior World Championship Top 7 placing in 2024
  - 5.2. An athlete's potential to win a medal
  - 5.3. An athlete's past result (Note: when considering 'results', factors other than the final placing may be taken into account these factors may include such things as the standard of the event, the draw, the opposition, officiating, injury and any other factors that may have influenced the final results)
  - 5.4. An athlete's stage of development and their ability to win a medal in the at future milestone events including European, World Championships and Olympic Games
  - 5.5. An athlete's commitment to the GB and/or HN Development Programme
  - 5.6. The athlete has won a minimum of 3 contests in a single Junior European Cup
  - 5.7. Wins against opponents on the IJF Senior World Ranking List top 36
  - 5.8. Current level of physical fitness
  - 5.9. Current and previous medical / injury history
  - 5.10. An athlete's suitability as a team member and/or as an ambassador for the BJA (Note: when considering 'suitability', factors such as behaviour and previous disciplinary record will also be taken into account).
- 6. If, after the Selection Panel has completed its consideration and selection of athletes under section 3, there are still spaces available in the GB Team delegation at the Second Selection Stage, the Selection Panel may then consider and select additional athletes to complete a full team Page 2 of 5

delegation if the Selection Panel deems such selection(s) would be beneficial to British Judo and/or the longer-term development of the athlete(s) concerned. Selections made under this section 5 shall be made as part of the Second Selection Stage. There shall be no obligation on the Selection Panel to select any athlete under this section 5. Athletes being considered for selection under this section 5 will be considered on an individual basis taking into account the factors listed in section 4.

All athletes who have met the Performance benchmarks at Continental Opens, Grand Prix, Grand Slams and stated Senior and Junior European Cups through the 2025 season (Home Countries, Great Britain or Self-funded) will be eligible for selection to the 2024 Junior World Championships.

7. Save in respect of any selection made pursuant to sections 2 & 3, the Selection Panel shall have the power to decide, at its discretion, and taking into what it considers will be in the best interests of British Judo, whether to select two, one or no athletes in any particular weight category.

The IJF Junior World Ranking List (WRL) is not considered as a performance standard for consideration of selection to the Junior European Championships, as WR points are accumulated over a 2-year rolling period, thus disadvantaging any fighter who only has a one year Junior performance competition programme. Additionally, as Bremen and Thuringia are key Junior events on the Junior circuit, but do not carry IJF Junior WR points, performances at these events would not contribute to a fighters overall Junior World Ranking.

#### TEAM EVENT

8. Should British Judo enter a team in the Junior World Team Championships, the Selection Panel shall select the team according to what it considers will be in the best interests of British Judo.

#### **SELECTION PANEL**

- 9. The selection Panel shall comprise of: the Chairperson, a minimum of three WCPP/GB Home Nation Elite Performance Coaches, the Head of Performance Pathways an Independent Observer and the Recording Officer. If the Performance Director or other personnel are unavailable for any reason, the Performance Director will nominate appropriate replacements.
- 10. The Chairperson shall be the Performance Director and shall be responsible for ensuring that due process is followed and decisions are made in accordance with this selection policy and the Head of Performance Pathways will also act as an observer to ensure that due process against the selection policy is followed.
- 11. Any selection decisions shall be made by way of a majority decision. Each WCPP/GB Home Nation Elite Performance Coach will have one vote each.
- 12. The Recording Officer of the Selection Panel will document selection decisions as appropriate. The Recording Officer will not be involved in the discussions other than to provide advice on nontechnical matters and will not be entitled to vote. The Independent Observer will observe to ensure that due process has been followed and will not be entitled to vote.
- 13. The GB WCPP Performance staff and the Recording Officer will be responsible for compiling results and other relevant details on athletes for consideration by the Selection Panel at selection meetings.

14. Any individual involved in the selection process must declare any association / conflict of interest concerning any athlete being considered for selection.

#### **COMMUNICATION OF SELECTIONS**

- 15. The Chairperson of the Selection Panel will provide the selection recommendations, together with any material that the Selection Panel considers appropriate to justify such selections, to the Performance Advisory Group ('PAG') for ratification. The PAG shall ratify the selections if the correct procedures were followed by the Selection Panel in the decision-making process.
- 16. Once selections have been ratified by the PAG, these will be immediately communicated to the relevant athletes by email and published on the BJA website.

#### FITNESS

17. Athletes may be required to undergo fitness tests and/or 'fit to compete' tests at any time.

#### PREPARATION

- 18. All WCPP athletes will follow the WCPP preparation programme.
- 19. All selected Team members will attend any planned Preparation Camps at the British Judo National Training Centre.

#### **ADIDAS JUDOGI**

20. It will be <u>compulsory</u> that all selected GB athletes for the 2025 Junior World Championships will wear Adidas Judogi in competition. The GB WCPP will provide 1x White and 1x Blue Adidas Judogi to each selected athlete.

All selected athletes will be responsible for purchasing and applying their backnumber to the Adidas Judogi in accordance to the IJF Judogi regulations. The backnumber can only be ordered from www.ijfbacknumber.com or www.mybacknumber.com.

#### **DE-SELECTION**

- 21. The Selection Panel shall have the power to de-select an athlete at any time if that athlete:
  - 21.1. does not fully participate in the event preparation and GB WCPP
  - 21.2. fails to follow safe weight making practice guidance and support
  - 21.3. fails to comply with any applicable anti-doping regulations
  - 21.4. in the opinion of the BJA medical staff, becomes medically unfit to compete as a result of injury or illness
  - 21.5. receives a suspension which prevents him/her from competing
  - 21.6. in the opinion of the BJA Elite Performance Coaches, fails to demonstrate the level of fitness expected

- 21.7. is guilty of misconduct or bad behaviour which the Selection Panel considers is sufficiently serious
- 21.8. acts in any way which is deemed to be detrimental to the BJA and/or its sponsors / partners.
- 22. Any athlete being considered for de-selection shall be notified by the Chairperson of the Selection Panel before any decision is made in this regard. Such notification must be in writing and must set out brief details of the reason(s) why the athlete is being considered for de-selection ('Deselection Notice'). That athlete shall then have the opportunity to provide his / her response to the points / issues raised in the De-selection Notice. Such response must be in writing and must be received by the Chairperson of the Selection Panel within 48 hours of the athlete's receipt of the De-selection Notice. The Selection Panel shall take into consideration any response received by an athlete.
- 23. In the event that the Selection Panel decides to exercise its power under section 22, it shall submit any proposed selection change(s), together with any material that the Selection Panel considers appropriate to justify its decision, to the PMG for ratification. The PMG shall ratify the selection change(s) if the correct procedures were followed by the Selection Panel in the decision-making process.
- 24. Once selection change(s) have been ratified by the PMG, these will be immediately communicated to the relevant athlete(s) by email and published on the BJA website.
- 25. The Selection Panel shall have the ability to replace any de-selected athlete(s). Athletes being considered as replacements under this section 25 will be considered on an individual basis taking into account the factors listed in section 6 and the provisions of sections 15 and 16 shall apply.

#### SELECTION PANEL DECISIONS

FUNDED UK Sport

- 26. Subject to section 28, and without prejudice to the Selection Panel's ability to de-select athletes in accordance with the provisions set out in sections 21 to 23, the decisions of the Selection Panel shall be final once ratified by the PMG.
- 27. In the event that the PMG does not ratify a selection or de-selection decision, the PMG shall refer that decision back to the Selection Panel for reconsideration. The Selection Panel may re-submit that selection decision to the PMG.
- 28. An athlete may only appeal a selection or de-selection decision on the grounds that the Selection Panel failed to follow the applicable criteria. The BJA Fast Appeals process is the only method of appeal should an athlete wish to appeal a selection or de-selection decision. Any appeal must be made within 24 hours of the selection or de-selection decision being communicated to the athlete.
